NOTICE OF PUBLIC HEARING BY THE CITY COUNCIL OF THE CITY OF PORT HUENEME TO CONSIDER APPROVAL OF SPECIAL USE PERMIT 01-21, TO CONDUCT A ONE-DAY CANNABIS FARMERS MARKET SALES EVENT, LOCATED AT HUENEME BEACH PARK, PARKING LOT "C"

NOTICE IS HEREBY GIVEN that a public hearing will be held by the City Council of the City of Port Hueneme to consider an application by Dan Eisenstein on behalf of From the Earth, 2675 Ventura Road Port Hueneme, CA 93041, for a temporary Special Use Permit (SUP) No. 01-21 for a cannabis sales event to occur on May 30, 2021 from 10:00 a.m. to 3:00 p.m. The event will consist of sales of cannabis and other related products with no on-site consumption in Hueneme Beach Parking Lot "C", located at 550 E. Surfside Drive, Port Hueneme.

SAID PUBLIC HEARING will be held on April 5, 2021, at 6:30 p.m., or as soon as possible thereafter. Interested persons are invited to attend via the electronic link provided in the published agenda for this meeting, which can also be accessed on the City's website. Due to the closure of the City Council Chamber and in compliance with Executive Order N-29-20, testimony for Public Hearing items may be submitted via US Mail or by email to the City Clerk. Testimony must be submitted in written form prior to 5:00 p.m. on the date of the Hearing and will be read into the record by the Mayor and made part of the Hearing Record in accordance with Executive Order N-29-20.

ENVIRONMENTAL REVIEW: The proposed SUP is deemed categorically exempt from review under the California Environmental Quality Act under California Code of Regulations Title 14 §§15301, 15304 (e) 15308, and 15323, because it establishes rules and procedures to permit operation of existing facilities; minor temporary use of land; ensures maintenance, restoration and protection of the environment; and regulates normal operations of facilities for public gatherings.
