

**NOTICE OF PUBLIC HEARING BY THE CITY COUNCIL OF THE CITY OF PORT HUENEME, TO CONDUCT A ONE-DAY CAR SHOW, LOCATED AT HUENEME BEACH PARK, PARKING LOTS "B" AND "C" AND OCEANVIEW DRIVE**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the City Council of the City of Port Hueneme to consider an application by Frank Montelongo on behalf of the Port Hueneme Police Department and Port Hueneme Police Explorers Post 9988, 250 N. Ventura Road, Port Hueneme, CA 93041, for a temporary Special Use Permit (SUP) No. 14-21 for a car show to occur on June 27, 2021 from 7:00 a.m. to 3:00 p.m. The event will consist of a car show with 150-275 vehicles, up to 13 vendor/food booths, and a DJ playing music in Hueneme Beach Parking Lots "B" and "C", located at 550 E. Surfside Drive, and along Oceanview Drive, Port Hueneme.

SAID PUBLIC HEARING will be held on June 7, 2021, at 6:30 p.m., or as soon as possible thereafter. Interested persons are invited to attend via the electronic link provided in the published agenda for this meeting, which can also be accessed on the City's website. Due to the closure of the City Council Chamber and in compliance with Executive Order N-29-20, testimony for Public Hearing items may be submitted via US Mail or by email to the City Clerk. Testimony must be submitted in written form prior to 5:00 p.m. on the date of the Hearing and will be read into the record by the Mayor and made part of the Hearing Record in accordance with Executive Order N-29-20.

ENVIRONMENTAL REVIEW: The proposed SUP is deemed categorically exempt from review under the California Environmental Quality Act under California Code of Regulations Title 14 §§15301, 15304 (e) 15308, and 15323, because it establishes rules and procedures to permit operation of existing facilities; minor temporary use of land; ensures maintenance, restoration and protection of the environment; and regulates normal operations of facilities for public gatherings.
