

RESOLUTION NO. 4406

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT HUENEME CALLING AND GIVING NOTICE OF THE MUNICIPAL GENERAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 8, 2022, FOR THE ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA, AND REQUESTING THE VENTURA COUNTY BOARD OF SUPERVISORS CONSOLIDATION OF SAID ELECTION WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON SAID DATE PURSUANT TO SECTION 10403 OF THE ELECTIONS CODE

WHEREAS, under the provisions of the law in the State of California, a General Municipal Election shall be held on November 8, 2022, the date of the statewide General Election; and

WHEREAS, The City of Port Hueneme calls for and gives notice of said General Municipal Election for the purpose of electing three members to the Port Hueneme City Council; and

WHEREAS, in accordance with Sections 10002, 10403, and 10418 of the California Elections Code, it is desirable for the General Municipal Election to be consolidated with the Statewide General Election being held on the same date and, that within the City, the precincts, polling places, and election officers of the two elections be the same, and that the County of Ventura Election Division canvass the returns of the General Municipal Election, and that the election be held in all respects as if there were only one election; and

WHEREAS, the City of Port Hueneme wishes to have the County Clerk of Ventura render specified services and supplies to the City relating to the conduct of the election.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Port Hueneme, that a General Municipal Election is hereby called to be held in the City of Port Hueneme on November 8, 2022, the date of the statewide General Election, for the purpose of electing three (3) Councilmembers for a full term of four years, as shown on Exhibit "A" attached hereto and made a part hereof.

BE IT FURTHER RESOLVED ballots to be used at the election shall be in the form and content as required by law.

BE IT FURTHER RESOLVED that pursuant to Section 10403 of the Elections Code, the Board of Supervisors of the County of Ventura is hereby requested to consent and agree to consolidation of a General Municipal Election with the Statewide General Election on November 8, 2022 for the purpose of the election of two members to the City Council

BE IT FURTHER RESOLVED The City Council acknowledges that the consolidated election will be held and conducted in the manner prescribed in Elections Code Section 10418.

BE IT FURTHER RESOLVED The City Clerk is authorized, instructed and directed to procure and furnish any and all printed matter and all supplies, equipment and necessary materials that may be necessary in order to properly and lawfully conduct the election.

BE IT FURTHER RESOLVED Notice of the time and place of holding the election is hereby given, and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

BE IT FURTHER RESOLVED that pursuant to Elections Code Section 10002, the Board of Supervisors is requested to permit the County Clerk to render services and supplies with respect to the conduct of the City of Port Hueneme's November 8, 2022 General Municipal Election (as shown on Exhibit "B" attached hereto and made a part hereof), that the County Clerk render any and all other services and supplies, as may be necessary to complete this election, and that the City of Port Hueneme pay the reasonable costs for the services and supplies rendered by the County Clerk.

BE IT FURTHER RESOLVED that the City of Port Hueneme authorizes the Board of Supervisors of the County of Ventura to canvass the election returns of the City of Port Hueneme's November 8, 2022 Municipal General Election. Pursuant to Section 15651 of the Elections Code, and in the event of a tie vote, the County election board shall determine the tie by random drawing.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to file a certified copy of this Resolution with the Ventura County Board of Supervisors and the Ventura County Elections Division.

BE IT FURTHER RESOLVED In all particulars not recited in this Resolution the election shall be held and conducted as provided by law for holding municipal elections in the City.

BE IT FURTHER RESOLVED that the City Clerk shall certify to the passages and adoption of this Resolution into the book of original resolutions.
